Public Enhancement and Services Program Rehabilitation of City Hall Bldg. which shall be funded under after having been post-qualified and declared to have obtained the Lowest Calculated Responsive Bid, has been recommended for award by the Bids and Awards Committee (BAC) of Davao City by virtue of **BAC Resolution No.04-052, Series of 2017** and the same has been approved by the City of Davao thru the undersigned at the contract amount of **Fifteen Million Two Hundred Six Thousand Three Hundred Two Pesos (Php 15,206,302.00)**. You are hereby requested to manifest your acceptance of the said award.

Relative thereto, and in accordance with the provisions of the bid documents and Revised R.A. No. 9184, otherwise known as the Government Procurement Reform Act and its Implementing Rules and Regulations, you are hereby instructed to furnish the City Government of Davao, the following documents within ten (10) calendar days from the date of your receipt of this Notice of Award to wit:

A. PERFORMANCE SECURITY

This is to be posted in favour of the City of Davao, in the form of cash, manager's check, cashier's check, bank draft/guarantee confirmed by local bank, irrevocable letter of credit issued by a reputable bank, surety bond callable upon demand, issued by the Government Service Insurance System or any reputable surety or insurance company duly accredited by the Office of the Insurance Commissioner, or a combination thereof IN ACCORDANCE with the following schedule:

a) Cash, cashier's/manager's check, bank draft/guarantee confirmed by a Universal or Commercial Bank.	Ten Percent (10%)
b) Irrevocable letter of credit issued by a Universal or Commercial Bank: Provided, however, that it shall be confirmed or authenticated by a Universal or Commercial Bank, if issued by a foreign bank.	Ten Percent (10%)
c) Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security.	Thirty Percent (30%)
d) Any combination of the foregoing.	Proportionate to share of form with respect to total amount of security

Within the same period of ten (10) days as indicated above, you are directed to enter into and execute the Infrastructure Contract.

This Performance Security shall be forfeited in favor of the City Government of Davao in the event it is established that you are in default in any of your obligations under the Contract.

The Right to institute action on the penal bond pursuant to Act No. 3688 of any individual firm, partnership, corporation and association supplying the contractor with labor and materials for the prosecution of the work is hereby acknowledged and confirmed.

Finally, it must be noted that you shall not commence the work nor initiate the procurement of materials for the project prior to your receipt of the Notice to Proceed.
