## **EXECUTIVE ORDER NO. 02**

Series of 2021

## AN ORDER PROVIDING FOR MANDATORY IMPLEMENTATION OF THE SAFE DAVAO QR AND OTHER PURPOSES

**WHEREAS,** the World Health Organization (WHO) has declared a COVID-19 pandemic;

**WHEREAS,** President Rodrigo Duterte issued Presidential Proclamation 1021 extending the State of Calamity in the country until September 12, 2021;

**WHEREAS,** Contact Tracing is a component in the response of the City to the Covid-19 pandemic;

**WHEREAS,** on November 3, 2020, Executive Order No. 60 s. 2020 providing for the guidelines of the Safe Davao QR (DQR) was released;

**WHEREAS,** the DQR is the electronic contract tracing program intended for use in the city;

**WHEREAS,** on November 9, 2020, the Regional Inter-Agency Task Force (RIATF), by virtue of Resolution No. 11, approved the Safe Davao QR for use by all offices and establishments in compliance to the Department of Trade and Industry and Department of Labor & Employment (DTI-DOLE) requirement of contact tracing log and will replace the paper and pen method of tracing forms;

**WHEREAS,** based on the pilot testing, the system can now function for the purpose it was developed, thus, mandatory implementation of its use can now proceed;

**WHEREAS,** there is a need to identify the specific areas where contact tracing must be used;

**NOW, THEREFORE, I, SARA Z. DUTERTE,** Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. SCANNING.** All individual offices and establishments shall be required to scan the DQR of the individuals entering their premises or post their establishment DQR ready for scanning by individuals, EXCEPT:

- 1) Offices and establishments that are not enclosed or are not inside a structure with a roof and walls, for example: milk tea stall, ambulant vendor, lechon manok stand, sari-sari store, bakery, palengke stall, etc.
- 2) Buildings that contain several offices or stores inside, such as malls, hospitals, commercial complex, etc. In this case, individual stores and offices should be the establishment that will scan the DQR.

**SECTION 2. MANDATORY.** The scanning of the DQR for the purpose of contact tracing shall be mandatory for all individuals and establishments beginning February 3, 2021.


