AN ORDER RECONSTITUTING THE TASK FORCE TO MONITOR, EVALUATE AND SPEED UP THE IMPLEMENTATION OF ALL SPECIAL/PRIORITY INFRASTRUCTURE PROJECTS OF THE CITY GOVERNMENT OF DAVAO

WHEREAS, the City Government is serious in its commitment to deliver all the development projects to its constituents the soonest possible time;

WHEREAS, it has been observed that there are several slippages on some infrastructure projects of the City Government of Davao;

WHEREAS, there is also the need to ensure the efficient utilization of the available machineries and equipment of the City Government of Davao in accomplishment of the said special/priority projects;

WHEREAS, all identified special/priority projects demand for regular constant attention to avoid the unwarranted delays that may cause inconvenience to the people and hinder the advancement of these infrastructure services;

WHEREAS, the Chief Executive finds it necessary to organize a pool of technical experts to monitor and evaluate the progress and development of the said programs and projects of the city;

NOW THEREFORE, to meet the above exigencies, and for the best interest of public service, I, **SARA Z. DUTERTE**, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Creation, Constitution and Composition of the TASK FORCE to Monitor and Evaluate all the Priority/Special Infrastructure and Projects of the City Government.

There is hereby a need to reconstitute the TASK FORCE ON SPECIAL PROJECTS. The TASK FORCE shall be composed of the following:

SECTION 2. SUPPORT STAFF. In order to keep the TASK FORCE effective in the performance of its functions, it is hereby authorized to organize and constitute its Support Staff or the Technical Staff from among employees of the different offices of the City Government.

SECTION 3. FUNCTIONS. The Committee shall exercise the following functions and responsibilities:

- 1) To expedite the implementation of the priority/special infrastructure projects;
- 2) To closely monitor or oversee all action required and taken by the various offices involved;
- 3) To push for regular cooperative action, initiates move to motivate common interest and concern for the uninterrupted execution of the projects and awareness of the critical time frame to be followed in implementing them;
- 4) To provide regular technical assistance to reinforce and fill-up the major work vacuum created by unexpected delays due to unforeseen circumstances to cope up with project backlogs;
- 5) To ensure the efficient and proper utilization of the machineries and equipment of the City Government of Davao;
- 6) Recommend to the City Mayor any changes in policies and systems that will be of help to speed up the progress of the infrastructure projects; and
- 7) To submit a monthly report to the City Mayor.

For purposes of this Section, the priority/special projects referred to herein are those with estimated total cost of P 5,000,000.00 and above while those projects with an estimated total cost of less than P 5,000,000.00 shall remain under the administrative control and supervision of the City Engineer.

SECTION 4. SUPPORT OF DEPARTMENTS/OFFICES. In compliance with this Order, all departments/offices of the City Government of Davao are hereby enjoined to extend their full administrative and technical support for the fast-tracking of the projects under this Order.

SECTION 5. OPERATIONAL EXPENSES AND FUNDING. Such amount as may be necessary for the effective operation of this TASK FORCE is hereby authorized to be appropriated and allotted subject to the usual government accounting and auditing rules and regulations.

SECTION 6. EFFECTIVITY. This order s	shall take effect immediately.
