EXECUTIVE ORDER NO. 11

Series of 2019

"AN ORDER AMENDING SECTION 3 OF EXECUTIVE ORDER NO. 10 SERIES OF 2017 TO INCLUDE CITY ORDINANCE NO. 0410-18, SERIES OF 2018 OTHERWISE KNOWN AS "THE SOBRIETY ORDINANCE OF DAVAO CITY" AMONG THE ORDINANCES TO BE IMPLEMENTED BY THE INTERIM VICES REGULATION UNIT OF THE OFFICE OF THE CITY MAYOR"

WHEREAS, Section 16 of the Republic Act No 7160 known as the Local Government Code provides that local government units shall exercise the powers expressly granted, those necessary implied therefrom, as well as the powers necessary, appropriate, or incidental, for its efficient and effective governance, and those which are essential for the promotion of the general welfare;

WHEREAS, Section 455 of the same Code expressly empowers the City Mayor to exercise general supervision and control over all programs, projects, services and activities of the city government and is mandated to appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in the said Code, as well as those he may be authorized by law to appoint:

WHEREAS, the same Section of the Code vests upon the City Mayor the power to enforce all laws and ordinances relative to the governance of the city and issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinance;

WHEREAS, the City Government is currently confronted with various challenges and concerns in relation to the implementation and observance of the provisions of the City Ordinance No. 0367-12, Series of 2012 known as the New Comprehensive Anti-Smoking Ordinance of Davao City, Ordinance No. 004-13, Series of 2013, otherwise known as the Liquor Ban Ordinance, Ordinance No. 064-02, Series of 2002, known as "An Ordinance Prohibiting Retailers, Wholesalers, Grocery Stores, Convenience Stores and other Businesses from Selling or Allowing to be Sold to Minors in their Respective Store and Establishments Cigarettes and other Tobacco Products, Beer, Liquor and other Intoxicating Beverages and Prohibiting All Minors, Aged 17 and Below from Buying Ordering and Serving, Selling or Drinking Beer, Liquor, Coconut Wine, Ordering or Smoking cigarettes and Other Tobacco Products from Wholesale, Retail Grocer or Convenience Stores and all other Business Establishments in the City of Davao" in relation to Section 7 of Ordinance No. 0292-06 known as the Davao City Children's Welfare Code, as amended, and other similar vice regulating measures of the City;

WHEREAS, Executive Order No. 10 Series of 2017 otherwise known as "An Order Creating and Organizing the Interim Vices Regulation Unit of the Office of the City Mayor, Defining its Functions, and For Other Purposes" does not include City Ordinance No. 0410-18, Series of 2018 otherwise known as "The Sobriety Ordinance of Davao City" among the ordinances to be implemented by the Interim Vices Regulation Unit;

WHEREAS, there is a need to include City Ordinance No. 0410-18, Series of 2018 otherwise known as "The Sobriety Ordinance of Davao City" among the ordinances to be implemented by the Interim Vices Regulation Unit;

NOW, THEREFORE, I, **SARA Z. DUTERTE,** Mayor of the City of Davao, by virtue of the power vested upon me by law, do hereby order that Section 3, Executive Order No. 10, Series of 2017 shall be amended as follows:

SECTION 3. Duties and Functions — The functions and duties of the Vices Regulation Unit shall be as follows:

- a) Ensure effective and efficient enforcement of the provisions of Davao City Ordinance No. Ordinance No. 004-13, Series of 2013 known as *The Liquor Ban Ordinance*, City Ordinance No. 0410-18, Series of 2018 otherwise known as *The Sobriety Ordinance of Davao City*, Ordinance No. 064-06 in relation to Section 7 of Ordinance No. 0292-06 known as the *Davao City Children's Welfare Code*, which similarly prohibits the Selling as well as Buying, Ordering and Serving, Selling or Drinking Beer, Liquor, Coconut Wine, Ordering, Sale of Liquors, among others, to and by minors, and other vices regulating ordinances of the City;
- b) In coordination with the existing Anti-Smoking Task Force, be in the lead in the enforcement of the provisions of City Ordinance No. 0367-12, Series of 2012, known as the New Comprehensive Anti-Smoking Ordinance of Davao City.
- c) Such other functions as may be designated by the City Mayor in the future.

SECTION 4 – Funding– The personnel and operating expenses of the Vices Regulation Unit shall be sourced from the Office of the City Mayor.

SECTION 5 – Separability Clause – If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.

SECTION 6 – Effectivity – this Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified, or until a city ordinance creating and Ancillary Services Unit attached to the Office of the City Mayor shall have been approved and took effect.
