EXECUTIVE ORDER NO. 04
Series of 2019

"AN ORDER PROVIDING FOR THE TEMPORARY CLOSURE OF THE DAVAO CITY-PANABO CITY ROAD FROM THE INTERSECTION OF J.P. LAUREL AVENUE AND R. CASTILLO ST. (ALCANTARA) UP TO THE BOUNDARY OF DAVAO CITY AND PANABO CITY (LASANG), AND THE NORTHBOUND LANE FROM THE INTERSECTION OF J.P. LAUREL AVENUE AND R. CASTILLO ST. (ALCANTARA) UP TO F. TORRES ST., AS WELL AS R. CASTILLO ST. ON VARIOUS DATES"

WHEREAS, Section 21 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991," authorizes the local chief executive to temporarily close both national and local roads for athletic events that the local government unit concerned has sponsored, recognized or approved;

WHEREAS, Davao City is the official sponsor of the following events: 1.) IRONGIRLS, 2.) IRONKIDS, and 3.) the "Alveo Ironman 70.3 Davao Powered by Petron," a duly licensed and sanctioned triathlon event of the World Triathlon Corporation, to be held from March 22, 2019 until March 24, 2019 in the cities of Davao, Panabo, Tagum and the Municipality of Carmen;

WHEREAS, the said events are part of the sports development and tourism promotions of Davao City which will showcase to the world the scenic sights, hospitable people and abundant culture, not only the city, but the entire Davao Region, the island of Mindanao, and the Philippines as a whole;

WHEREAS, in order to ensure the successful staging of the said events and ensure public safety and security, the temporary closure of some roads in Davao City is required;

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the TEMPORARY CLOSURE of the following roads, and specifically during the dates and times herein below respectively provided, to wit:

- For the **IRONGIRLS** event, on March 22, 2019 (Friday), R. Castillo Street:
 - Northbound Lane only (going towards Lanang) from Go Green Gas Station to intersection of J.P Laurel Avenue and R. Castillo St. (Alcantara) from 3:00 pm to 7:00 pm.
 - Note: Southbound Lane (going towards Davao City Center) will be open and used for two-way traffic.
- For the **IRONKIDS** event On March 23, 2019 (Saturday), R. Castillo Street:

- Northbound Lane only (going towards Lanang) from corner Jerome St. to intersection of J.P Laurel Avenue and R. Castillo St. (Alcantara) from 4:00 am to 8:00 am.
 - Note: Southbound Lane (going towards Davao City Center) will be open and used for two-way traffic.

For the "Alveo Ironman 70.3 Davao Powered by Petron" event:

- On March 24, 2019 (Sunday), Davao City – Panabo City Road, specifically from the intersection of J.P Laurel Avenue and R. Castillo St. (Alcantara) up to the boundary of Davao City and Panabo City (Lasang):
 - Northbound Lane (going towards Tagum City) from 3:00 am to 12:30 pm.
 - Southbound Lane (going towards Davao City) from 3:00 am to 10:30 am.
- On March 24, 2019 (Sunday), J.P Laurel Avenue, specifically from the intersection of J.P Laurel Avenue and R. Castillo St. (Alcantara) up to F. Torres Street:
 - Northbound Lane (going towards Lanang) 3:00 am up to 3:30 pm.
 - Note: Southbound Lane (going towards Davao City Center) will be open and used for two-way traffic, but only up to Alcantara.

All persons affected hereby are advised to plan ahead their trips or use available alternate routes, or amend their schedules as may be deemed appropriate.


Finally, all national and local government offices in Davao City are hereby enjoined to provide their full and active support, and their utmost cooperation for the successful staging of all the foregoing events.

This Executive Order shall take effect immediately and shall last until the affected roads will be reopened to traffic by appropriate authorities.
