**AN ORDER FOR THE INCLUSION OF THE KALAHI-CIDSS KKB AREA COORDINATOR OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) AND PRE-SELECTED COMMUNITY VOLUNTEERS AS MEMBERS OF THE CITY DISASTER RISK REDUCTION MANAGEMENT COUNCIL (CDRRMC) AND FORMATION OF PRE-SELECTED VOLUNTEER FOR GRIEVANCE REDRESS SYSTEM COMMITTEE FROM THE CDRRMC FOR THE DURATION OF KAPIT-BISIG LABAN SA KAHIRAPAN COMPREHENSIVE AND INTEGRATED DELIVERY OF SOCIAL SERVICES (KALAHI CIDSS) PROGRAM IMPLEMENTATION IN THE CITY OF DAVAO**

**WHEREAS**, Section 3 (g) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that the capabilities of local government units, especially the municipalities and barangays shall be enhanced by providing them with opportunities to participate actively in the implementation of national programs and projects;

**WHEREAS**, Section 25(b) of the same Act provides that the national agencies and offices with project implementation functions shall coordinate with the local government units concerned in the discharge of these functions and that they shall ensure the participation of local government units both in the planning and implementation of said national projects;

**WHEREAS**, the City of Davao signed and entered into a Memorandum of Agreement (MOA) and Specific Implementation Arrangements (SIA) with the Department of Social Welfare and Development (DSWD) to establish a partnership aimed at providing the constituents with the most appropriate recovery measures to cushion the impact of Covid-19 in its locality as well as to implement a social protection program that will address the needs of the poor and marginalized and promote inclusive growth in the LGU through the KALAHI-CIDSS Program;

**WHEREAS**, the City of Davao established a partnership with the DSWD aimed at providing the Davaoeños with the most appropriate recovery measures to cushion the impact of Covid-19 as well as to implement a social protection program that will address the needs of the poor and marginalized sector and promote inclusive growth through KALAHI-CIDSS Program;

**WHEREAS**, the KALAHI CIDSS Program to be implemented in Davao City includes the CASH FOR WORK project in the amount of TWENTY FIVE MILLION (P25,000,000.00) PESOS with the 12 Barangays as target beneficiaries, namely: BUCANA 76-A, TALOMO PROPER, MATINA APLAYA, DUMOY, 8-A, 21-C, 22-C, LANGUB, MAGTUOD, 18-B, 36-D, AND 3-A;



**WHEREAS**, the implementation of the said CASH FOR WORK project under the KALAHY-CIDSS program of the DSWD requires the inclusion of the KALAHY-CIDSS KKB Area Coordinator and three (3) Community Volunteers to the City Disaster Risk Reduction Management Council (CDRRMC) for the duration of its program implementation that will aid in addressing public concerns and complaints relative to the implementation of the program.

**WHEREAS**, the implementing Rules and Regulations (IRR) of RA 10121 provides the policy of the states to adopt among others, a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socioeconomic and environmental impacts of disaster including climate change and promote the involvement and participation of all sectors and all stakeholders concerned at all levels especially the local community;

**WHEREAS**, while the IRR of RA 10121 enumerated the composition of the LDRRM members, it expressly stated that the membership shall not be limited to what was enumerated thereon;

**WHEREAS**, their inclusion to the CDRRMC is deemed vital and strategic in ensuring effective and efficient implementation of the said program within its period of implementation;

**NOW THEREFORE, I, SARA Z. DUTERTE**, by virtue of the power vested in me by law as the City Mayor of the City of Davao, do hereby order:

**SECTION 1. Provisional Membership to CDRRMC.** The following shall be included as members to the City Disaster Risk Reduction Management Council (CDRRMC) for the duration of KALAHY CIDSS-Program implementation only, to wit:

- a. KALAHY CIDSS Area Coordinators
- b. The three (3) Community Volunteers who shall be composed of the following individuals selected by the recipient barangay through a Barangay Council Resolution, to wit:
  - i. Chairman-Barangay Sub-Project Management Committee (BSPMC)
  - ii. Head-Project Implementation Team (PIT) Committee
  - iii. Head-Operation and Maintenance (O&M) Committee

**SECTION 2. Duties and Functions.** The foregoing included members of the CDRRMC shall form part of the Councils performance of its functions for the duration of their membership especially on matters that pertains and/or related to their program implementation as follows:

- a. Approved, monitor, and evaluate the implementation of the local DRRM plans and annually review, test and develop the plan consistent with other National and other planning programs;
- b. Ensure the integration of disaster risk reduction and climate change adaption into local development plans, programs, and budgets as a strategy in sustainable development and poverty reduction;
- c. Recommend the implementation of forced or pre-emptive evacuation of local residents. If necessary; and
- d. Convene the local council as provided by law and pertinent rules.

**Section 3. Role of the Barangays.** Barangays mentioned above are directed to immediately submit the names of the community volunteers to become the member of the CDRRMC.

**Section 4. Grievance Redress System Committee.** The CDDRMO shall identify three (3) persons among the community volunteers mentioned above as members of the Grievance Redress System during the implementation of the Cash For Work Project.

**Section 5. Separability Clause.** If any section or part of this Order is held unconstitutional or invalid the other sections or provisions not otherwise affected shall remain in full effect.

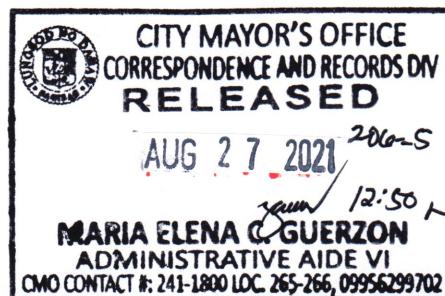
**Section 6. Effectivity.** This Executive Order shall take effect immediately and shall cease to effect after the implementation of the pertained Program has been duly completed or terminated.
