EXECUTIVE ORDER NO. 65

Series of 2020

**AN ORDER CONSOLIDATING ALL THE ISSUANCES
ON THE USE OF FACE SHIELDS**

WHEREAS, the World Health Organization (WHO) has declared a COVID-19 pandemic;

WHEREAS, President Rodrigo Duterte issued Presidential Proclamation 1021 extending the State of Calamity in the country until September 12, 2021;

WHEREAS, there is a need to create a guide for Davao City residents where the use of face shield is mandatory and its basis;

NOW, THEREFORE, I, SARA Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. MANDATORY. The following are the issuances that make face shield mandatory in certain areas:

- A. Department of Transportation (DOTr) Memorandum Circular No. 2020-014 dated August 3, 2020, mandates the mandatory wearing of face shield with a face mask for all passengers in areas where public transportation is allowed;
- B. Department of Trade and Industry (DTI) and Department of Labor and Employment (DOLE) Joint Memorandum Circular No. 20-04-A dated August 15, 2020, which shall apply to all private establishments regardless of economic activity including economic zones, mandates the use of face shield with a face mask with the following guide:

II. Workplace Safety and Health

B. Reducing Transmission of COVID-19

b. Face shields

- i. Face shields shall cover the entire face (completely cover the sides and length of the face). If possible, face shields should extend to the ears and below the chin.*
- ii. Visor-type face shields shall not be allowed.*
- iii. Face shields and masks should always be worn together when interacting with colleagues, clients, and/or visitors.*
- iv. Face shields may be removed according to the demands of the work or when the occupational safety and health of the employees so requires. (i.e., working near a fire or in the kitchen, operating a machine, etc.)*

C. Inter-Agency Task Force (IATF) Resolution No. 68, s. 2020 dated September 3, 2020, mandates the use of a face shield with a face mask in the following places: supermarkets, public markets, malls, and in venues where government initiated meetings and critical government services are being conducted or provided.


D. Davao City Police Office (DCPO) and all its camps and police stations for all the guests accessing all police services.

SECTION 2. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 3. REPEALING CLAUSE. All Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY. This Order shall take effect immediately.
