## EXECUTIVE ORDER NO. 03

## AN ORDER CREATING THE CITY PALARONG PAMBANSA ORGANIZING COMMITTEE TO BID FOR THE CITY'S HOSTING OF THE 2026 PALARONG PAMBANSA

**WHEREAS**, it is the policy of the state to promote physical education and encourage sports programs, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

**WHEREAS**, the City Government supports and promotes genuine sports development programs by providing avenues for athletes to actively participate in their respective sports through organizing local sports competitions and in partnership with national and international competitions;

**WHEREAS**, pursuant to the principle of rotation, which is the "Visayas-Luzon-Mindanao-Luzon" cycle adopted in its hosting, the Island of Mindanao will be the venue of the 2026 Palarong Pambansa, an annual multi-level national scholastic athletic competition;

**WHEREAS**, there is a need to create a local body tasked to plan and organize the City's bid to host the 2026 Palarong Pambansa.

**NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE**, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CREATION**. There is hereby created a City Palarong Pambansa Organizing Committee to be composed of the following:

Chairperson : Vice Chair : Members :

Davao City Schools Division Superintendent

City Mayor or in his absence, the City Administrator

- Assistant City Administrator for Operations
- Head, City Treasurer's Office
- Head, City Mayor's Office City Sports Division
- Head, City Information Office
- Head, City Engineer's Office
- Representative, University of the Philippines Mindanao
- Head, Public Safety and Security Office

SECTION 2. DUTIES AND FUNCTIONS OF THE CITY PALARONG PAMBANSA ORGANIZING COMMITTEE. The Committee shall have the following duties and functions:

1. Plan, prepare, and organize the city's bid to host the 2026 Palarong Pambansa, including the following:

- a. Identify the sports facilities to be used, which must be of international standards, billeting areas for the athletic delegations and technical officials, and other infrastructure requirements and provisions pursuant to the criteria for the Selection of Venue for the Palarong Pambansa;
- b. Prepare and accomplish all the prerequisites, documentary or otherwise, which may be required by the Palarong Pambansa Board;
- c. Secure the manifestation of all socio-economic-political groups, government, and non-government agencies in the region declaring uncompromising unity in ensuring the successful staging of the Palarong Pambansa;
- 2. Perform such other functions as may be necessary to achieve its goals.

**SECTION 3. FUNDING**. The operating expenses of the Committee shall be funded by the Office of the City Mayor.

**SECTION 4. SEPARABILITY CLAUSE.** If any provision of this Executive Order is declared invalid of unconstitutional, the other provisions are not affected and thereby shall remain valid and subsisting.

**SECTION 5. REPEALING CLAUSE.** All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.


**SECTION 6. EFFECTIVITY**. This Executive Order shall take effect immediately upon its approval and remain effective unless revoked or modified.
