EXECUTIVE ORDER NO. 21
Series of 2024

**AN ORDER RECONSTITUTING THE MEMBERSHIP OF THE DAVAO CITY
DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL, PROVIDING FOR
ITS FUNCTIONS, DUTIES, AND FOR OTHER PURPOSES**

WHEREAS, the Philippine Congress enacted Republic Act No. 10121 or the "Philippine Disaster Risk Reduction and Management Act of 2010";

WHEREAS, Section 11 of the same Act provides for the organization of a disaster council at the local government level;

WHEREAS, Section 12 of the same Act requires the establishment of an office which shall be responsible for setting the direction, development, implementation, and coordination of disaster risk management programs within its territorial jurisdiction;

WHEREAS, it is the policy of the State to uphold its citizens' constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction management, and building the resilience of local communities to disasters;

WHEREAS, the Davao City Disaster Risk Reduction and Management Council was initially created and constituted under Executive Order No. 07, Series of 2012 and subsequently reconstituted through Executive Order No. 16, Series of 2014; Executive Order No. 23, Series of 2019, Executive Order No. 53, Series of 2019, and Executive Order No. 35, Series of 2022, consecutively;

WHEREAS, the City Government of Davao should develop, promote, and implement a comprehensive Davao City Disaster Risk Reduction and Management Plan that aims to strengthen the capacity of the local government unit, together with partner stakeholders, to build disaster-resilient communities, and to institutionalize arrangements and measures for reducing disaster risks. These include projecting climate change risks, enhancing disaster preparedness, and developing response capabilities at all levels;

WHEREAS, it is the responsibility of the Davao City Local Government Unit to provide maximum care, assistance, and services to individuals and families affected by disasters, implement emergency rehabilitation projections to lessen the impact of disasters, and facilitate resumption of normal social and economic activities;

WHEREAS, it is the duty of the LGU to engage the participation of other government institutions, Civil Society Organizations, the private sector, and volunteers in the local government unit's disaster risk reduction programs towards proper use of resources and effective delivery of service to the citizenry.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. RECONSTITUTION AND COMPOSITION. The City Disaster Risk Reduction and Management Council (CDRRMC) is hereby reconstituted and shall be composed of the following:

Chairperson: City Mayor or his duly authorized representative

- Head, Integrated Gender and Development Division (IGDD)
- Head, City Engineer's Office (CEO)
- Head, City Veterinarian's Office (CVO)

- Head, Ancillary Services Unit (ASU)
- Head, City Legal Office
- Head, City Accountant's Office
- Head, Barangay and Cultural Communities Affairs Division (BCCAD)
- City Schools Division Superintendent, Department of Education (DepEd)-

- Commander, Task Force Davao (TFD)
- Commander, Coast Guard Station Davao (CGSD)
- City Director, Davao City Police Office (DCPO)
- City Fire Marshall, Bureau of Fire Protection (BFP)

 - University of the Philippines – Mindanao

SECTION 2. FUNCTIONS OF THE CDRRMC. As provided for under Section 11 (b) of Republic Act No. 10121, the following are the functions of the Council:

1. Approve, monitor, and evaluate the implementation of the Local Disaster Risk Reduction and Management Plans (LDRRMP) and regularly review and test the plan consistent with other national and local planning programs.
2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs, and budgets as a strategy in sustainable development and poverty reduction.

3. Recommend the implementation of forced or pre-emptive evacuation of local residents, if necessary.
4. Convene the local council once every three (3) months or as often as necessary.
5. Perform such other functions that are incidental to and are necessary for the performance of disaster risk reduction and management.

SECTION 3. SECRETARIAT. The Davao City Disaster Risk Reduction and Management Office is hereby directed as the Secretariat who shall handle all administrative and secretarial functions of the CDRRMC.

SECTION 4. FUNDING/OPERATING COSTS. All costs pertaining to the operation of the CDRRMC including the payment of honoraria, incidental and other expenses to its members, and other appropriate personnel as may hereinafter be identified by the chairperson, shall be taken from the available funds of the City Government of Davao, subject to the usual accounting and auditing rules and regulations.

SECTION 5. REPEALING CLAUSE. All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE. If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.


SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately.
