EXECUTIVE ORDER NO. 27
Series of 2024

**AN ORDER CONSTITUTING THE MEMBERSHIP OF THE MUSEO DABAWENYO
ADVISORY BOARD, PROVIDING FOR ITS POWERS AND FUNCTIONS, AND
FOR OTHER PURPOSES**

WHEREAS, as stipulated in Republic Act No. 7160, otherwise known as the Local Government Code of 1991, local government units shall ensure and support, among other things, the preservation and enrichment of local culture, history, and heritage;

WHEREAS, the said provisions of the Code are anchored on the constitutionally-declared policy under Article II, Section 17 of the 1987 Philippine Constitution that the State shall give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress and promote total human liberation;

WHEREAS, it is the policy of the State to pursue and support the cultural development of the Filipino people, through the preservation, enrichment and dynamic evolution of Filipino national culture, based on the principle of unity in diversity in a climate of free artistic and intellectual expression;

WHEREAS, on October 17, 2006, the Sangguniang Panlungsod enacted City Ordinance No. 0266-06, otherwise known as the Davao City Museum Ordinance providing for the establishment of the Museo Dabawenyo;

WHEREAS, Section 7 of Ordinance No. 0266-06, states that the business of the museum shall be conducted by the Museo Dabawenyo Advisory Board to be composed of the City Mayor as Chairperson, the Schools Division Superintendent of the Department of Education as the Vice-Chair, and the Chairpersons of the Sangguniang Panlungsod Committee on Education and Committee on Tourism, as well as the Chairperson of the Davao Historical Society and four (4) other representatives from the private sector, as members;

WHEREAS, there is a need to constitute the membership of the Museo Dabawenyo Advisory Board in accordance with the provisions in the aforementioned City Ordinance so that it may commence to discharge its powers and functions.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. CONSTITUTION AND COMPOSITION. The Museo Dabawenyo Advisory Board is hereby constituted and shall be composed of the following as reflected in Ordinance No. 0266-06:

Chairperson:	City Mayor or his duly authorized representative
Vice-Chairperson:	Schools Division Superintendent of the Department of Education Davao City Division

Members:

- Chairperson, Sangguniang Panlungsod Committee on Education, Science and Technology, Arts and Culture
- Chairperson, Sangguniang Panlungsod Committee on Tourism and Beautification
- Head, Museo Dabawenyo (Secretariat)
- Chairperson, Davao Historical Society
- Four (4) Representatives from the Private sector

As indicated in Section 8 of Ordinance No. 0266-06, the private sector representatives shall be appointed by the City Mayor from a short list nominated by recognized Non-Government Organizations (NGOs) in the Museum and cultural sectors, as well as by reputable business groups.

The private sector representatives shall be appointed for a term of three (3) years. Of those first appointed, two (2) Representatives shall be appointed for a three-year term; the other two (2) shall be appointed for a two-year term.

SECTION 2. FUNCTIONS. Pursuant to its mandate, the Museo Dabawenyo Advisory Board shall have the following functions:

- a. Shall serve in all advisory capacity on matters pertaining to Museo Dabawenyo operations and services.
- b. Shall be authorized to adopt an official seal which shall be judicially noticed as indicated in Section 9 of Ordinance No. 0266-06.
- c. Shall make such by-laws, rules, and regulations, as it deems necessary for the administration of its functions under the Museo Dabawenyo Ordinance.
- d. Shall make by-laws, rules, and regulations relating to the acquisition, exhibition, and loan of works of art.
- e. Shall handle the administration of the Museo Dabawenyo Trust Fund.
- f. Shall establish the organization and procedure of the Board.
- g. Shall determine the admission fees to augment the upkeep and maintenance expenses of Museo Dabawenyo.
- h. Shall appoint the Director of the Museo Dabawenyo.

SECTION 3. MEETINGS AND QUORUM. The Museo Dabawenyo Advisory Board may function notwithstanding vacancies, and, at any meeting of the Board, five (5) shall constitute a quorum to do business.


SECTION 4. FUNDING. All expenses necessary and incidental to the effective implementation of the operations of the Board shall be charged to funds made available for the purpose either through the Annual Budget or the Supplemental Budget of the City Government. The service as members of the Board shall be gratuitous. However, they shall be entitled to transportation allowance, subject to the availability of funds.

SECTION 5. SEPARABILITY CLAUSE. If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.

SECTION 6. REPEALING CLAUSE. All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified.
