## EXECUTIVE ORDER NO. <u>37</u>

## AN ORDER CONSTITUTING THE LUPONG TAGAPAMAYAPA INCENTIVES AWARDS - CITY AWARDS COMMITTEE (LTIA-CAC)

**WHEREAS**, as a community-based conflict resolution mechanism, the Katarungang Pambarangay has proven its effectiveness in perpetuating the time-honored Filipino tradition of settling interpersonal disputes amicably without resorting to confrontational social behavior. Successes have been largely attributed to the commitment and dedication of Lupon members in the performance of their duties and responsibilities;

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the Department of the Interior and Local Government (DILG) and the Local Government Units (LGUs) to provide a system of granting benefits and incentives to the Lupon, for the reason of exemplary performance;

**WHEREAS**, the DILG, through the Bureau of Local Government Supervision, has established the Lupong Tagapamayapa Incentives Awards (LTIA) to accord government recognition to the Most Outstanding Lupong Tagapamayapa in the country;

**WHEREAS**, in the furtherance of the objectives of the LTIA as established pursuant to Executive Order No. 394 series of 1997 and to sustain the gains of the awards, the guidelines relative thereto are reiterated and supplemented per Memorandum Circular No. 2008-102, "Reiterating and Supplementing DILG Memorandum Circular 2004 relative to the Lupong Tagapamayapa Incentives Awards Guidelines" and DILG Memorandum Circular 2016-58, "Reiterating and Supplementing DILG MC 2008-102 relative to the LTIA Enhanced Criteria and Guidelines;

**WHEREAS**, to carry out the task of determining the top performing Lupong Tagapamayapa in Davao City, there is a need to create a Lupong Tagapamayapa Incentives Awards – City Awards Committee.

**NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE,** Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1. CREATION AND COMPOSITION.** The Lupong Tagapamayapa Incentives Awards – City Awards Committee is hereby created and shall be composed of the following:

**SECTION 2. DUTIES AND FUNCTIONS.** The committee shall have the following duties and responsibilities:

- a. Initiate and coordinate the necessary activities toward the successful implementation of the LTIA in the city.
- b. Disseminate information on the Awards to generate awareness and support from the public and private sectors within the city.
- c. Select and submit to the Regional Awards Committee the best performing Lupon within the city.
- d. Secure funding and counterpart prizes from partner agencies.
- e. Plan and implement appropriate awarding ceremonies.

**SECTION 3. SECRETARIAT.** The Department of the Interior and Local Government shall act as the Secretariat and provide technical and secretarial services to the committee.

**SECTION 4. FUNDING.** All costs pertaining to the operation of the committee shall be charged to the allocation for Katarungang Pambarangay under Lump Sum Appropriations, subject to the usual accounting and auditing rules and regulations.

**SECTION 5. SEPARABILITY CLAUSE.** If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.


