EXECUTIVE ORDER NO. 40

Series of 2024

AN ORDER RECONSTITUTING THE DAVAO CITY MIGRATION AND DEVELOPMENT COMMITTEE, DEFINING ITS POWERS, FUNCTIONS, AND DUTIES

WHEREAS, the Philippines remains as one of the major sources of labor supply worldwide with its citizens migrating to other countries for employment;

WHEREAS, migration can be regarded as a positive force for development as long as the right set of policies and guidelines are in place;

WHEREAS, Local Government Units (LGUs) have a significant role in strengthening the developmental impact of migration, both local and international;

WHEREAS, Regional Development Council (RDC) XI recognized the role of LGUs in the dissemination of information to its constituents on all aspects of migration and development concerns;

WHEREAS, RDC XI, through Resolution No. 54, Series of 2018, enjoins the local government units in the Davao region to create local migration and development committees to address migration-related concerns;

WHEREAS, Ordinance No. 0411-20, Series of 2020, otherwise known as the Creation of the Davao City OFW Families' Welfare and Crisis Center under the City Social Welfare and Development Office, and its Implementing Rules and Regulations as set forth under Executive Order No. 67, Series of 2022, focuses on the protection of the rights, interests, welfare and development of the Davao City-based left-behind households of documented OFWs who are also Davao City residents;

WHEREAS, the City Government of Davao issued Executive Order No. 13, Series of 2021 – An Order Creating the Davao City Migration and Development Committee, Defining Its Powers, Functions, and Duties;

WHEREAS, there is a need to reconstitute the abovementioned Executive Order in order for the Committee to continue delivering its duties and functions.

NOW, THEREFORE, I, SEBASTIAN Z. DUTERTE, Mayor of the City of Davao, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. RECONSTITUTION AND COMPOSITION. There is hereby reconstituted the Davao City Migration and Development Committee which shall be composed of the following:

SECTION 2. FUNCTIONS. The Committee shall have the following duties and responsibilities:

- a. Conduct research and data collection activities regarding the migration profile of the city (i.e. number of migrants, destination of country of migrant, employment status, average annual remittances received by the family of the migrant, among others).
- b. Formulate and implement policies, services, and programs catering to migrants and their families, particularly in the following four (4) program areas: social protection and welfare services, economic development services, advocacy, and educational services in line with the directions of the Davao Regional Development Plan.
- c. Include migration and development in the local development plan, local development investment program/annual investment program.
- d. Ensure that migration and development is encompassed in the vision, statement, mission, and goals or other local policies of the city.
- e. Mainstream the services of the city which cater to migrants and their families.
- f. Monitor and assess the effectivity and impact of the abovementioned programs and services.

- g. Coordinate with the OFW Families' Welfare and Crisis Center under the City Social Welfare and Development Office (CSWDO) as may be necessary.
- h. Perform such other functions as may be directed by the City Mayor.

SECTION 3. SECRETARIAT. The City Social Welfare and Development Office shall be the Secretariat of the Committee. It shall be tasked to handle all administrative and/or secretarial-related activities and shall ensure all meetings of the Committee are effectively organized and recorded.

SECTION 4. TECHNICAL WORKING GROUP. There shall be created a Technical Working Group to assist the Committee in the discharge of its functions whose composition shall be determined by the members of the Committee.

SECTION 5. BUDGET. There shall be a budget allocated from available and appropriate resources to fund the operations and activities of the Committee, including meetings, seminars, trainings, capacity-building, and other administrative costs, subject to the usual accounting and auditing rules and regulations.

SECTION 6. SEPARABILITY CLAUSE. If any part or provision of this Executive Order shall be declared invalid, the other portions or provisions hereof which are not affected thereby, shall continue in full force and effect.

SECTION 7. REPEALING CLAUSE. All other Orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified.
